Subject: Invitation of Proposal for Development Grant for the year 2015-16.

Sir/Madam,

As you are aware, the UGC is providing financial assistance to the eligible Open and Distance Learning Institutions (ODLs) on the pattern of erstwhile Distance Education Council (DEC).

2. Proposals are invited for financial assistance from SOUs for the financial year 2015-16 in the prescribed format attached with this letter. A copy of the format is also available on UGC website (www.ugc.ac.in/deb).

3. The UGC proposes to create a central repository of the high quality interactive study material in print, multimedia and e-mode. The SOUs would be the substantial contributors to this repository and therefore, would be required to provide 5 copies of the printed SLM, soft copy and transfer the copyright to UGC with regard to each of the programmes developed with the financial assistance from erstwhile DEC and UGC. It is therefore, requested to furnish an undertaking/affidavit in the prescribed format on non-judicial stamp paper of Rs.100/- duly notarized along with the proposal.

4. The following documents are required to be submitted by the SOUs to be eligible for the financial assistance for the financial year 2015-16:

- (a) Copy of the letter of UGC for continuation of recognition of your university for the year 2015-16.
- (b) Statement of Expenditure/Utilization Certificate with respect to the development grant for the year 2014-15, duly signed by the Competent Authority, against the grant sanctioned to your university for the financial year 2014-15, if any.
- (c) Audited accounts of 2013-14, duly certified by Government Auditors, and
- (d) Affidavit, as mentioned above regarding the copyright of the SLM.

5. Two hard copies along with a soft copy of proposal, complete in all respect duly signed and stamped by the competent authority of the University should reach the Joint Secretary (DEB), University Grants Commission, Bahadur Shah Zafar Marg, New Delhi on or before **15th September, 2015.**
