study objectives of the study, scope of the study and Hypotheses of the study are also discussed. The chapter ends with the Chapter plan.

The second chapter has dealt with the review of literature related to various aspect of the theme of Research like tourists satisfaction with respect to Accommodation, Food and beverage, Transport, Ancillary Service Providers and Miscellaneous determinants. Based on the extensive review of literature, the scholar has developed the conceptual and operational framework for the study.

The third chapter entitled 'research methodology' covers the research design. Research setting expresses the area and sample of study, questionnaire development, sampling design, sampling method, research instrument, data collection, data analysis technique and procedure and comprehensively explains the various variables.
