MEMORANDUM OF UNDERSTANDING (MOU) FOR PROMOTION OF EDUCATION FOR THE EMPOWERMENT OF PERSONS WITH DISABILITIES

The Memorandum of Understanding (MoU) between Uttarakhand Open University, Haldwani

(hereinafter referred as "UoU, Haldwani") having its office at Transport Nagar, University Road,

Haldwani- 263139 and the Rehabilitation Council of India (hereinafter referred as "RCI"), a Statutory

Body under Ministry of Social Justice and Empowerment, DEPwD, Govt. of India, having its office at

B-22, Qutub Institutional Area, New Delhi-110016 was Signed on 16.01.2015 for collaboration in

promoting education through distance mode for the empowerment of person with disabilities for a

period of 05 years upto 15.01.2020.

In pursuance of the above MoU, Special Education courses namely B.Ed. Special Education,

through Open & Distance Learning mode (B.Ed.Spl.Edn.-ODL) in the area of Intellectual and

Developmental Disabilities, Visual Impairment, Hearing Impairment & Learning Disability were

successfully implemented with an encouraging acceptability and increasing demand.

The present MoU is an extension of the MoU signed between UoU, Haldwani and RCI, New

Delhi on 16.01.2015 for collaboration in promoting education for the empowerment of persons with

disabilities and is governed by the following provisions:

1. The UoU, Haldwani will collaborate with RCI in designing programme and development of

multimedia for Special Education courses through Open & Distance Learning (ODL) and will

facilitate delivery and certification of such courses.

2. RCI recognizes UoU, Haldwani as State Open University equipped to undertake Special

Education courses through Open & Distance Learning (ODL) in Hindi & English medium.

RCI will also extend technical expertise to UoU, Haldwani and its Study Centres as and

when required.

- 4. Training programme(s) through ODL mode for B.Ed.Spl.Ed. shall be conducted as per the prescribed norms and regulations of RCI. SLM shall be developed by the UoU, Haldwani in light of the revised syllabus.
- 5. For aforesaid training programmes, the faculty and infrastructural facilities at the University, academic contents, eligibility conditions, and process of evaluation etc. shall be as prescribed by the RCI from time to time.
- 6. All the Special Education training programmes to be conducted in future need to be planned on Self-Financing and Self-Sustaining Scheme with generation of funds through course fees and other charges to meet the running cost of the course.
- 7. The amount of the Programme Fee and other charges is to be decided jointly by RCI & UoU, Haldwani to meet the financial implications for self-financing. No other fee or any other amount shall be charged by UoU, Haldwani from the students.

- On the basis of the criteria mentioned at Clause (5), course fees will be shared by the UoU, Haldwani, RCI and the Study Centre(s) on PRORATA basis as per the norms fixed for each course as per need. The norm of sharing of course fees and other charges shall be fixed on a long-term perspective as per the following proportion;
 - (a) **UoU**, **Haldwani** 50% of the total fee and charges collected in r/o special education courses and other courses as mentioned at Clause (3).
 - (b) **Study Centre:** 40% of the total fee and charges collected in r/o special education courses and other courses as mentioned at Clause (3).
 - (c) RCI: 10% of the total fee and charges collected in r/o special education courses and other courses as mentioned at Clause (3).
- 9. Study Material in respect of aforesaid courses will be provided by UoU, Haldwani to Study Centres and students as per the requirement.
- 10. Training institutions already running the B.Ed.Spl.Ed. training programme approved by the Council in the State of Uttarakhand shall only be considered as a Study Centre(s), subject to fulfilment of the prescribed eligibility conditions to become study centres as mentioned in the revised B.Ed. Spl.Ed.–ODL norms, 2021
- 11. UoU, Haldwani will provide the list of prospective Study Centre(s) to RCI for issuance of NOC to act as a Study Centre under UoU, Haldwani
- 12. In case approval is not further extended to any training institutions for conducting B.Ed. Spl.Ed. programme through face-to-face mode, the eligibility to become Study Centres will automatically stands cancelled. However, the students already enrolled in the study centre concerned will be allowed to continue the course within the time frame as stipulated under Clause-3.
- 13. UoU, Haldwani and RCI will jointly decide the norms in respect of the honorarium to the faculty and detailed process of admission, examination and evaluation etc.
- 14. UoU, Haldwani shall conduct the training programmes as per the prescribed syllabus of RCI and shall also conduct examination and award Marksheet and degree to the students.

- 17. The present MoU shall be valid for a period of 5 years w.e.f. 16.01.2020 and may be renewed from time to time at 5 (five) years of interval on mutual agreement. However, it may also be terminated earlier by either party giving advance notice of one academic session.
- 18. Both the parties hereto agree that any dispute arising out of this MoU shall be settled mutually though discussions and that in the event of their failure to settle the dispute, the matter shall be referred to Sole Arbitrator appointed with the consent of both the parties in New Delhi.
